## INFORMATION POLICY OF THE SERVICE PROVIDER

a warning about the risks associated with the services provided and the possession of FND vouchers, Cryptocurrencies, including the rules on excluding the civil liability of the Service Provider.

Before deciding to use FutureNet services, you are required to familiarize yourself with the warnings about risk and exclusions of civil liability provided below and accept them as part of the distribution agreement:

## Section I.

- 1. You explicitly accept and agree that the Service Provider does not guarantee any profits in connection with the activities of Marketing Associate s in the sale of FutureNet Goods/Services, and the amount of Remuneration received by Marketing Associate s depends on the effectiveness of actions taken by the Marketing Associate himself, actions taken by other Users in the Distribution Structure, revenues generated by the Service Provider himself, market conditions and other factors of an economic or personal nature, and anything expressed by the Marketing Associate s as regards the revenues constitutes only examples and under no circumstances should be understood as a guarantee or promise or guarantee of obtaining the same profits from the Service Provider.
- 2. You explicitly accept and agree that any examples of the possibility of obtaining a specific Remuneration and also possible outcomes that may occur in connection with the distribution of goods or providing other services to the Service Provider, resulting from the Marketing Plan and other official documents of the Service Provider, should be treated only as examples, assumptions and/or estimates and under no circumstances should they be understood as suggested or otherwise possible expectations regarding Remuneration, let alone as guarantees or promises of Remuneration or other income. The Remuneration that can actually be obtained or other income may change significantly or even not occur or occur to a very limited extent, because they depend on a large number of unpredictable personal and economic factors and variables. In particular, the expected actual Remuneration or other benefits depend on the efforts of each individual person involved in the distribution and require as in any business activity very large and continuous efforts in the area of distribution.
- 3. You explicitly accept and agree that no predictions, or statements about the amounts in the

- future, can be made on the basis of a previously received Remuneration, commissions, or other income because they are also, in accordance with the paragraph (2), dependent on a large number of unpredictable factors and variables.
- 4. The Service Provider strongly advises you that when making decisions regarding the commencement of distribution activities on his behalf, you do not rely on information provided by third parties about payments of Remuneration, commissions or other income, as well as information from other Service Provider's Marketing Associate s regarding allegedly obtained Remuneration or other income, because such advertising of distribution activity is strictly prohibited under the contractual terms for each Marketing Associate, especially since the obtained Remuneration of one Marketing Associate can not be compared, duplicated or reflected with the expected results of another Marketing Associate.
- 5. You accept that the Service Provider does not bear any responsibility for the content spoken or published by the Marketing Associate s in the scope of how to conduct business under FutureNet Business and Future AdPro Platform, the amount of Remuneration they earn, as well as in the scope of their possession cryptocurrencies and trading in them.

## Section II.

- You accept that in connection with the effective intermediation in the sale of FutureNet Goods/Services and the provision of other services, the Marketing Associate - after meeting the criteria set out in Marketing Plans - may receive remuneration from the Service Provider only in the form of FNDolar (FND) vouchers, which do not constitute any currency, Cryptocurrency or legal tender.
- 2. You accept that FND vouchers are only time-limited vouchers valid for 3 years from the date of their receipt which can be exchanged for FutureNet Goods/Services as part of the FutureNet Biznes and Future AdPro Platforms, subject to the provisions contained in the Distribution Agreement, Terms and Conditions and Marketing Plans.
- 3. You accept that 50% of the FND vouchers received as Remuneration may be redeemed, unless FutureNet agrees to redeem them in a bigger amount. Then on the terms set out in the Distribution Agreement and Terms and Conditions in exchange for redeemed FND vouchers, the Marketing Associate receives their equivalent in US Dollars or selected cryptocurrency (in the case of FutureAdPro only in cryptocurrency).

- 4. You accept that, as part of the FutureAdPro Portal, the purchase of new Advertising Packages and the generation of FND codes in the case of FND Vouchers received as remuneration is possible only from the part (that is available) for redemption.
- 5. You accept that the cryptocurrency market is a highly volatile market and at the same time it is extremely speculative. If you decide to redeem an FNDolar voucher and receive its equivalent in the form of cryptocurrencies, you are aware that their possession and trading in them entail a significant risk of loss, and in extreme cases may even lead to the total loss of their value.
- 6. You accept and agree that the Service Provider does not guarantee any profits in connection with the possession of cryptocurrencies, and all utterances and statements of the Service Provider or other Marketing Associate s, therefore, should be treated only as a private opinion and not as a guarantee or recommendation regarding the sale, having or trading cryptocurrencies.
- You declare that you are a person with business experience in the possession and trading of
  cryptocurrencies and are ready to bear economic, legal, tax and other risks related to your
  acquired cryptocurrency;
- 8. You declare that you have knowledge about the cryptocurrency you may receive after redeeming the FNDolar voucher and factors affecting its value.
- 9. You declare that you are aware that in accordance with the laws, stance of authorities or courts in your country, possession and trade in cryptocurrencies may not be legally permissible or obtaining certain permits may be necessary for this purpose. At the same time, you declare that you are aware that in such a case the Service Provider does not bear any criminal, fiscal-penal or civil liability in connection with your actions regarding possession of or trading in cryptocurrencies.
- 10. You accept that according to the above warnings the Service Provider does not guarantee any profits nor takes any responsibility for the legality of possession of or trade in cryptocurrencies in the country of your or Marketing Associate's residence.
- 11. You accept and agree that the Service Provider, having regard to the volatility of the cryptocurrency market, is entitled, in the event of significant market circumstances, e.g. significant loss of value of a given cryptocurrency (on cryptocurrency exchanges), to partially limit or terminate at any time without prior announcement of offering exchange of FND voucher for a given cryptocurrency without providing a reason.
